Issue:	This document provides guidance for transporting lithium batteries by air as identified by IATA.ORG. The Dangerous Goods Regulation (DGR) for lithium batteries is found in the IATA Lithium Battery Shipping Guidelines (LBSG). Please see <u>www.iata.org</u> for documentation of the most recent DRG. Also, it is important to note that specific shipping companies may have stricter requirements versus the documented guidelines.
	As stated in the DRG Section C7 of the 58 <sup>th</sup> Edition: Companies that are involved with reverse logistics, i.e. arranging for returns of lithium batteries, lithium batteries packed with equipment or lithium batteries contained in equipment must develop a clear instruction for consumers on the process to be followed for returning products. This instruction must include packaging materials and lithium battery marks are necessary. The instruction must also include the transport method and mode of transport that must be followed; this must include a clear statement on applicable prohibitions.




